The nomination form and associated nomination fee are not transferable to another horse. If mare does not foal, the entry fee may be applied to the following year. The nomination fee is not refundable.

The mare must be a purebred Arabian who is registered with the Arabian Horse Association or the Canadian Arabian Horse Registry. The nomination form must be entirely filled in, signed and include the nomination fee before the entry will be accepted. For a resultant foal to be eligible for futurity classes, the mare must be nominated and the **\$165.00 nomination fee** must be paid by **December 31st** of the year the mare is bred or a late fee will result.
